IN ADDITION TO THE TENANCY AGREEMENT I AGREE TO THE FOLLOWING CONDITIONS FOR KEEPING PETS IN PROPERTIES

- 1. My pet will not be allowed to create any nuisance (through noise, behaviour, fouling or smell) to other residents of the scheme, staff and visitors or in the local neighbourhood.
- 2. Any fouling by my pet in my garden, the communal areas of the scheme or in the neighbourhood must be cleaned up to a satisfactory standard, as defined by MSV, and the faeces must be hygienically disposed of.
- 3. If I live in a flat, I/we understand that my dog should be kept on a lead at all times in any communal areas and will only be allowed in the communal areas for the purpose of entering or leaving the scheme.
- **4.** I/we agree to meet any costs incurred in repairing any damage to the garden or communal areas by my pet.
- 5. I/we understand that I must provide the details of at least two nominated people who agree, in writing, to take full responsibility for the care of my pet, the event that I should not be able to.
- 6. I/we understand that in the event that my nominated people are not able to care for my pet I will have to find a local care provider (e.g. kennels) to provide this service.
- 7. My pet will be kept clean, well groomed, properly fed and exercised.
- 8. I/ we understand that no more than one pet is allowed, unless I have written authority from MSV to keep additional pets.
- **9.** I/ we understand that the breeding of animals is not allowed.
- **10.** I/we understand that MSV have no responsibility for my / our pets, responsibility rests with the tenant
- **11.** I /we understand that no pet can be brought to live or stay with a tenant until permission has been granted to keep a pet.
- **12.** I / we understand that a breach of these conditions will result in a breach Tenancy Conditions and legal action will be brought on the relevant grounds, if necessary.
- **13.** I / we agree to complete this pet agreement.
